- No use of squirt-guns, super-soakers or similar items
- No consumption of alcoholic beverages at any time
- Animal entries require a City permit (available at the City Hall)
- All units and participating walkers must keep up with the unit ahead of them
- All participants agree to hold the Legendary Lake Mills and the Board of Directors harmless for any and all damages from participation in the Community Parade. This agreement is implied by returning the completed entry form
